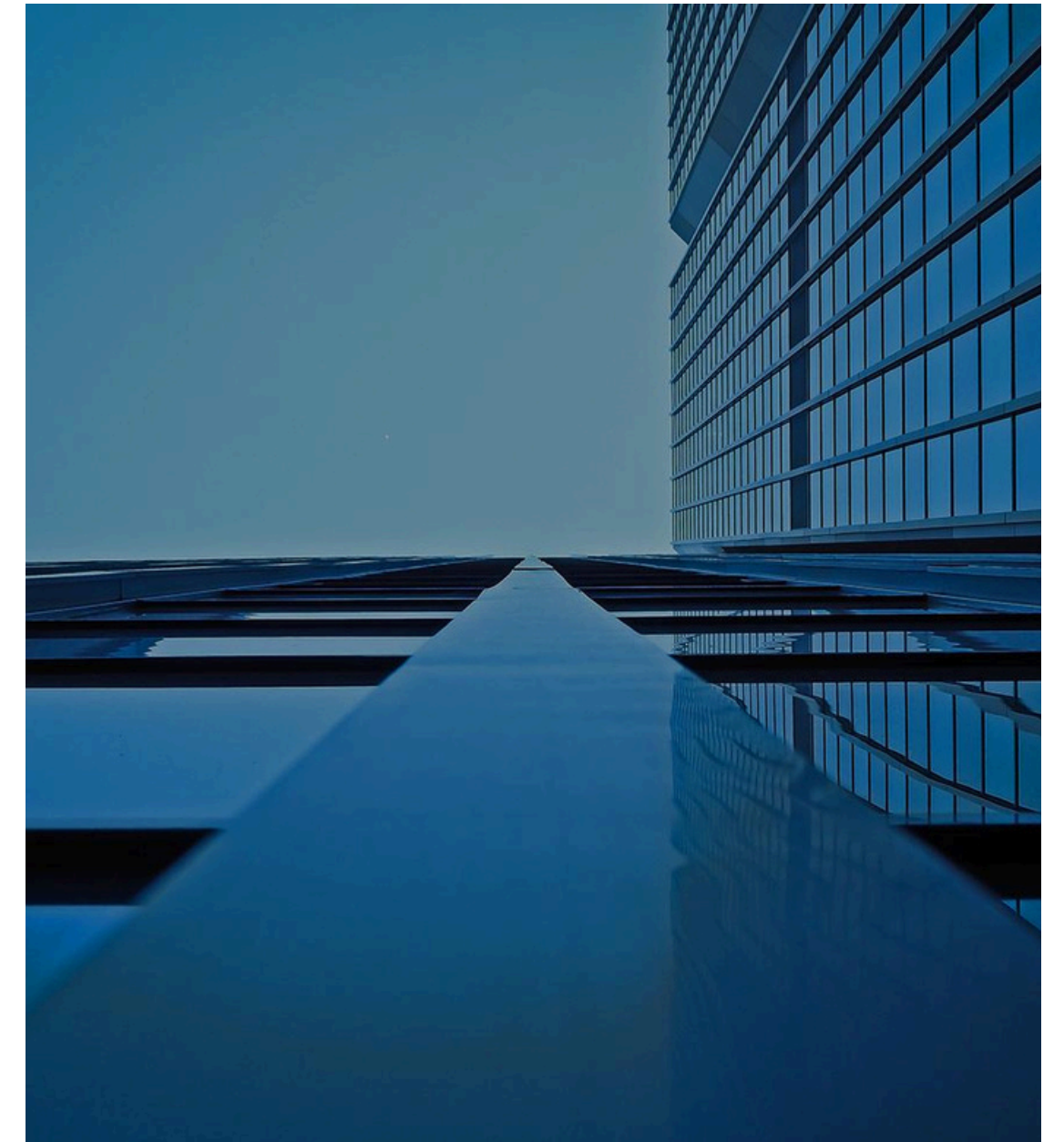

***Note:** Individuals can also be owners of trademarks.

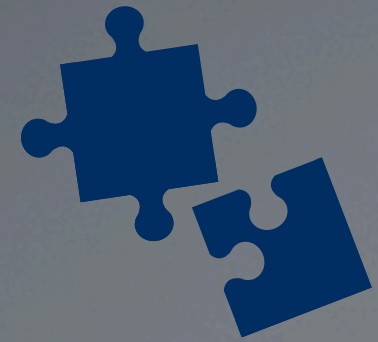


INTELLECTUAL PROPERTY

COPYRIGHT

Copyright means rights of an organization or individual to works which such organization or individual created or owns.

- Copyright arises from the moment a work is created and fixed in a tangible form, regardless of whether it has been registered.
- Copyright registration enables authors or copyright owners to proactively protect their rights and eliminates the burden of proof in the event of a dispute.

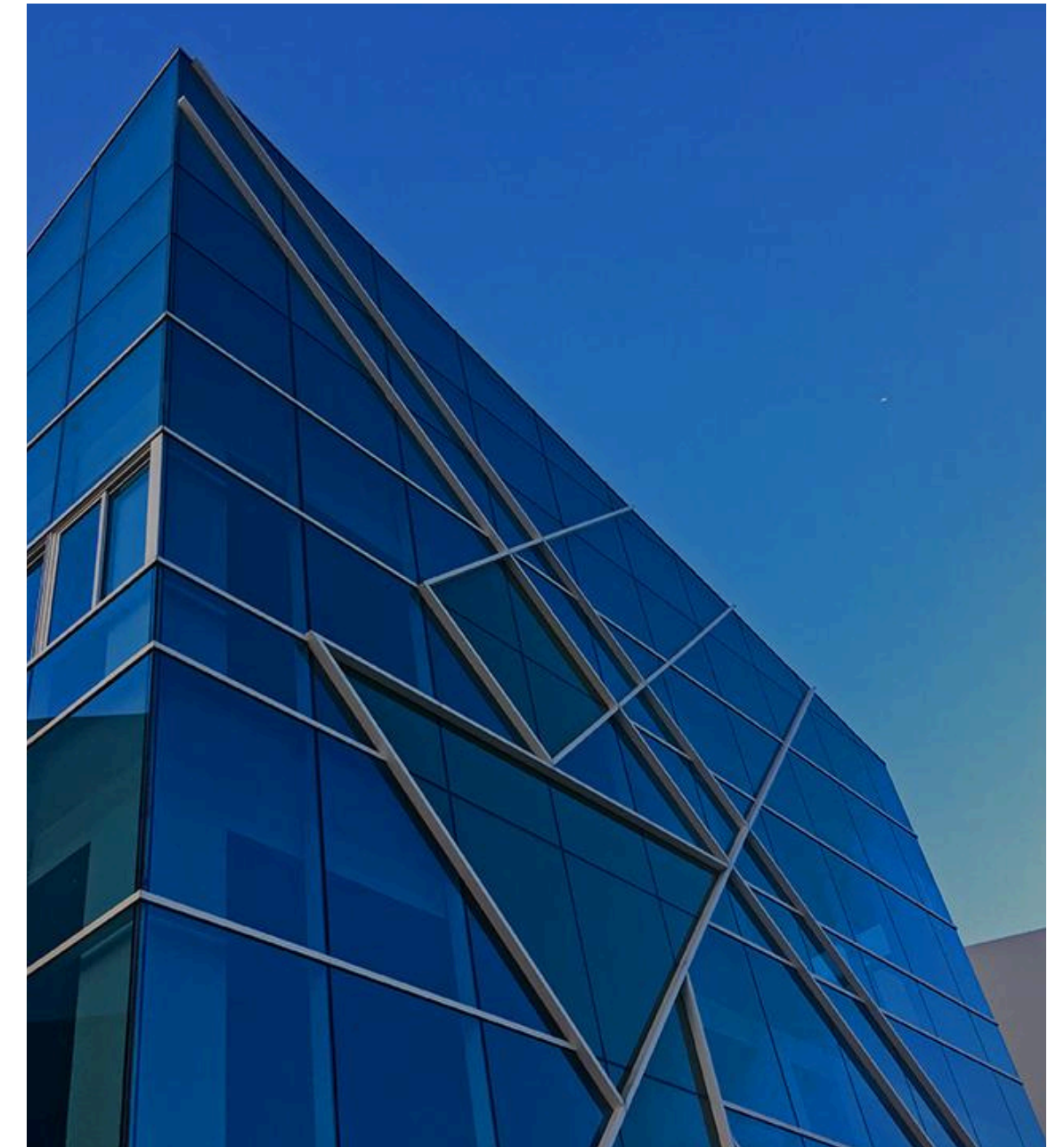


CONTRACT
